**REQUEST FOR EXTENSION OF TIME
TO MAKE INFORMATIONAL FILING**

COMES NOW Cintex Wireless, LLC (“Cintex”) and, for its request, states as follows:

1. On September 9, 2011, Cintex filed an application with the Missouri Public Service Commission (“Commission”) seeking designation as an Eligible Telecommunications Carrier (“ETC”) in order to receive federal universal service support for low income customers through Lifeline and LinkUp programs.

2. The Commission issued its Order granting Cintex’s application for ETC designation on December 21, 2011, with an effective date of December 31, 2011.

3. Pursuant to 4 CSR 240-3.570(3)(D), Cintex must make an informational filing with the Commission consisting of a complete description of all of its service offerings within thirty (30) days of receiving ETC status. Such filing is due on or before today, January 30, 2012. Cintex hereby requests that it be given a ninety-day extension in which to make such informational filing. If it can be made sooner, then Cintex promptly will make that filing.

4. Counsel for Cintex has discussed this request for an extension of time with Staff, which does not object to this request.

WHEREFORE, Cintex Wireless, LLC requests that the Commission grant it an additional ninety (90) days, until April 30, 2012, to make its informational filing pursuant to 4 CSR 240-3.570(3)(D).
