**SUPPLEMENTAL STAFF RECOMMENDATION**

COMES NOW the Staff of the Missouri Public Service Commission and for its supplemental recommendation states:

1. On July 13, 2006, the Staff filed its Recommendation for approval of the proposed interconnection agreement between Trans National Communications International, Inc., and AT&T Missouri. The Staff uses the term interconnection agreement to refer to the two documents - - (1) the Interconnection Agreement under Sections 251 and 252 of the Telecommunications Act of 1996 and (2) the Commercial Agreement<sup>1</sup> - - which together constitute the whole interconnection agreement. Both documents were filed with the application.

2. In Case No. TK-2005-0304, *In the Matter of the Application of Missouri RSA No. 5 Partnership, d/b/a Chariton Valley Wireless for Approval of an Interconnection Agreement with Southwestern Bell Telephone Company, L.P. d/b/a SBC Missouri Pursuant to Section 252(e) of the Telecommunications Act of 1996*, the Commission rejected an interconnection agreement. The companies had entered into an interconnection agreement and a transit service agreement. The transit service agreement was not before the Commission. The Commission found that it is against the public interest to approve only part of an interconnection agreement; the whole of which should be before the Commission and, if approved, subject to adoption by other carriers.<sup>2</sup>
