## ORDER CONSOLIDATING FILES

On June 4, 2010, Kansas City Power & Light Company (“KCPL”) and KCP&L Greater Missouri Operations Company (“GMO”) submitted to the Commission proposed tariff sheets intended to implement general rate increases for electrical service provided in their Missouri service areas. The proposed tariff sheets bear effective dates of May 4, 2011.<sup>1</sup> On June 11, 2010, the Commission issued notice of both actions, set intervention deadlines and set tentative dates for evidentiary hearings.

Because the newly-filed rate cases involve the Iatan plant additions to KCPL and GMO,<sup>2</sup> the Commission will consolidate the file for the construction audit and prudence review (EO-2010-0259) with each of the new files (ER-2010-0355 and ER-2010-0356).

**THE COMMISSION ORDERS THAT:**

1. The Commission's Data Center shall transfer a copy of all docket sheet items in File No. EO-2010-0259 into File Nos. ER-2010-0355 and ER-2010-0356.
2. Any data requests and responses, and any other discovery devices used in association with the construction and prudence audits in File No. EO-2010-0259 are transferred into File Nos. ER-2010-0355 and ER-2010-0356.
3. All future filings related to the construction and prudence audits of Iatan I and Iatan II shall be submitted to all three files.
4. This order shall become effective immediately upon issuance.
