
1. The Company has main offices in Missouri located at 112 East 32nd Street, Joplin, MO 64804.



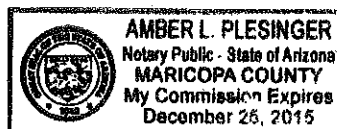
