Riley understands and agrees that the hedge price has a 2% inflation adjustment that he did not include. The affected numbers in his rebuttal testimony are in Schedules JSR-R-2 and JSR-R-4 and the expected revenues and hedging costs values that appear on pages five and nine, which are taken from Schedules JSR-R-2 and JSR-R-4. Therefore, corrected pages five and nine, and Schedules JSR-R-2 and JSR-R-4 are provided with this notice. Note that Schedule JSR-R-4 was inadvertently omitted with the original filing. That Schedule is the same as Schedule JSR-R-2, except that the return on equity was revised
