MOTION FOR EXTENSION

COMES NOW the Staff of the Missouri Public Service Commission ("Staff") and for its *Motion for Extension* respectfully states as follows:

1. On July 2, 2021, Union Electric Company d/b/a Ameren Missouri ("Ameren Missouri") filed its *Application for Modification of Demand Side Management Plan, and Approval of Associated Variances* ("Application"), with supporting information and testimony, seeking approval of the modification of its Demand-Side Management Portfolio and Plan for years 2019-2021 in order to extend the plan's effective date through December 31, 2023.

2. The Commission issued its *Order Setting Time for Responses and Directing Staff Recommendation* on July 8, 2021, ordering Staff to file a recommendation regarding Ameren's Application or, in the alternative, a status report indicating when Staff will be able to file a recommendation.

3. On July 15, 2021, Staff filed a *Status Report* explaining that Staff and Ameren Missouri had been discussing the Application, but due to ongoing commitments in Ameren Missouri's ongoing electric and gas rate cases under File Nos. ER-2021-0240 and GR-2021-0241, Staff requested to file its recommendation no later than September 13, 2021.

4. On August 9, 2021, the Commission granted Staff's request in its *Order Directing Staff Recommendation*, setting the new response date for September 13, 2021.

5. Parties have continued discussions regarding the Application, and hope to file a stipulation in lieu of any recommendations. To further this end, Staff requests an additional thirty days for parties to formalize and finalize a stipulation.

WHEREFORE, Staff files this *Motion for Extension*, and respectfully requests that the Commission issue an order setting October 13, 2021 as the filing date for any stipulation or recommendation in this matter.
