## NOTICE OF PARTY STATUS

On January 31, 2022, Evergy Missouri Metro and Evergy Missouri West filed an application to extend its Missouri Energy Efficiency Investment Act Cycle 3 programs an additional year. The Commission issued an order directing notice, and setting a deadline of February 21, 2022, for requests to intervene.

On February 14, 2022, Renew Missouri Advocates d/b/a Renew Missouri filed an application intervene. Renew Missouri previously filed an application to intervene in this matter on December 6, 2018, which the Commission granted. Because Renew Missouri is already a party in this case it is unnecessary to grant intervention.
