## ORDER DIRECTING RESPONSES

On December 28, 2022, Evergy Missouri Metro and Evergy Missouri West (collectively "Evergy") filed a substitute tariff sheet No. 49U under Tracking No. YE-2023-0110. Prior to the substitution, in a Commission order issued December 21, 2022, sheet No. 49U was approved to become effective on January 1, 2023. Evergy's filing letter accompanying the substitute tariff sheet did not explain the purpose or necessity of the substitution. Accordingly, the Commission will direct Evergy to file a pleading explaining the purpose and necessity of the substitution, and whether the Commission's Staff (Staff) has been informed of the changes. The Commission will also direct Staff to file a recommendation concerning the substitute tariff filing.

### THE COMMISSION ORDERS THAT:

1. No later than December 30, 2022, at noon, Evergy shall file a pleading explaining the purpose and necessity of the substitution, and whether Staff has been informed of the changes.
2. No later than December 30, 2022, at noon, Staff shall file a recommendation about Evergy's substitute tariff, Tracking No. YE-2023-0110.

3. This order is effective when issued.
