APPLICATION

COMES NOW Calvey Brook Sewer Inc. (hereinafter "Applicant"), pursuant to Section 393.170, RSMo. (1986), 4 CSR 240-2.060 and 4 CSR 240-3.305 and, for its application for a certificate of convenience and necessity authorizing it to construct, install, own, operate, control, manage, and maintain a sanitary sewer system for the public in an unincorporated area of Franklin County, Missouri, states to the Missouri Public Service Commission (hereinafter "Commission") as follows:

- 1. Applicant is a Missouri corporation duly organized and existing under the laws of the State of Missouri with its principal office and place of business located at 2801 West Osage, Suite 5, Pacific, Missouri 63069. A Certificate of Good Standing from the Missouri Secretary of State and Articles of Incorporation are attached to this Application (Exhibit A). No annual report or assessment fees are overdue at the time of the submission of this Application. By this Application, Applicant proposes to provide sewer service to the public as a public utility pursuant to the jurisdiction, regulation and supervision of the Commission.
- 2. Applicant does not have any pending action or final unsatisfied judgments or decisions against it from any state or federal agency or court which involve customer service or rates, which action, judgment or decisions has occurred within three (3) years of the date of the filing of this Application.

3. The verification required by Commission Rule 4 CSR 240-2.060(1)(M) is attached hereto and incorporated herein by reference (Exhibit B).

- 5. By this application, Applicant seeks permission, approval and a certificate of public convenience and necessity authorizing it to construct, install, own, operate, control, manage and maintain a sewer system for the public in an unincorporated area of Franklin, County, Missouri, as set forth on the map attached to this Application (Exhibit C) and as legally described by metes and bounds attached to this Application (Exhibit D).
- 6. Attached hereto and incorporated herein by reference is a feasibility study containing a description of the company, plans and specifications for the proposed facilities and estimated costs associated with the construction and operation of the proposed facilities during the first three (3) years; plans for financing; proposed rates and charges and an estimate of the number of customers, revenues and expenses during the first three (3) years of operation (Exhibit E).
 - 7. There are currently no persons residing in the proposed service area.
- 8. The proposed area of operation is part of Public Water District No. 2. However, according to the Franklin County Planning & Zoning Department the aforementioned water district exists on paper only and it has no active members. A letter waiving the preferential status cannot be obtained. The proposed area has no centralized septic service available. The only method of sewage treatment is "on-site" systems.

9. The Applicant is in the process of permit approval with the Department of Natural

Resources. A copy of all relevant correspondence is attached hereto and incorporated herein by

reference (Exhibit F).

10. The proposed area of operation will be Calvey Brook Estates with the limits of the

subdivision as recorded in the Franklin County Recorders Office. Calvey Brook Estates is a 36 lot

residential subdivision on approximately 25 acres and will be the only area served by the sewer system.

Franklin County Zoning Regulations require a dense subdivision to provide central sanitary sewer.

Several alternatives were available including construction of a three-cell lagoon, a mechanical treatment

facility, a sand filter system or a packed media bed system. The chosen packed media bed system will

provide the best central treatment system. The treatment facility will be located at the lowest point of

the subdivision. A public need exists for adequate sanitary sewer service within the proposed area of

operation and the public convenience and necessity will be promoted by the granting of the authority

requested herein.

WHEREFORE, Applicant respectfully requests that the Commission issue its order:

(a) Granting Applicant permission, approval and a certificate of convenience and necessity

authorizing it to construct, install, own, operate, control, manage and maintain a sewer utility system for

the public in an unincorporated area in Franklin county, Missouri, as more particularly described in

Exhibit C and Exhibit D; and

(b) Granting such further relief as the Commission deems appropriate.
