On September 20, 2018, The Empire District Electric Company filed an application for variances regarding the upcoming filing of its 2018 Integrated Resource Plan, which is required by the Commission's Electric Utility Resource Planning Rule, 4 CSR 240-22. In response to that application for variances, the Commission provided notice of the filing to potentially interested parties and ordered that any party wishing to intervene file an application to do so by October 10. The Missouri Department of Economic Development - Division of Energy and Renew Missouri Advocates d/b/a Renew Missouri filed timely applications to intervene. More than ten days have passed since those applications to intervene were filed and no one has responded to either application.

The Commission finds that allowing the Division of Energy and Renew Missouri to intervene will serve the public interest. Therefore, in accordance with Commission rule 4 CSR 240-2.075(3), the Commission will grant the applications to intervene.
