On March 21, 2019,<sup>1</sup> the Commission issued its Order Granting Consolidation, Setting Procedural Schedule, and Further Suspending True-Up Timeline. The Order set the case for an evidentiary hearing on August 27 and required initial briefs on September 16 and reply briefs on September 27. An evidentiary hearing occurred on August 27, and at the close of evidence the parties asked for a week's extension on their briefs. The Commission will amend the briefing schedule.

### THE COMMISSION ORDERS THAT:

1. The parties' initial briefs shall be filed no later than September 23, 2019.
2. The parties' reply briefs shall be filed no later than October 4, 2019.
3. This order shall be effective when issued.




