ORDER AND NOTICE

On March 28, 2008, Union Electric Company, d/b/a AmerenUE and Pemiscot-Dunklin Electric Cooperative, Inc., submitted to the Commission a Joint Application. The joint applicants want to transfer approximately 2,700 Dunklin County customers from AmerenUE to Pemiscot-Dunklin. To accomplish such a transfer, the joint applicants seek Commission approval of their request for a change in the electric supplier for those customers, approval for the sale of certain AmerenUE assets to Pemiscot-Dunklin, and approval of a territorial agreement between the applicants.

The Commission finds that proper persons should be allowed 20 days from the issuance of this order to file a motion for leave to intervene. The Commission's Data Center shall serve a copy of this order upon the county commission of Dunklin County. In addition, the Commission's Public Information Office shall make notice of this order

available to the media serving Dunklin County and to the members of the Missouri General Assembly representing Dunklin County.
