2. As the basis of this complaint, Complainant states the following facts:

WITHIN THIS PAST YEAR, SERVICE WITH AMEREN U.E. HAS GOTTEN WORSE. THERE HAVE BEEN NUMEROUS POWER OUTAGES AND POWER SURGES. THE STORMS THIS YEAR COULD NOT BE PREVENTED. WHAT COULD BE PREVENTED, HOWEVER, IS THE TRANSFER OF LOCAL U.E. CREWS OUT OF OUR AREA DURING STORMS. THIS LEAVES US WITH CREWS THAT DO NOT KNOW THE AREA. THE CREWS THAT WERE TRANSFERRED HERE HAD OUTDATED MAPS AND COULD NOT FIND THE AREAS WITH DOWN WIRES. THIS CREATED LONGER POWER OUTAGES. WE ARE ALREADY PRIORITY 5 IN GETTING OUR POWER RESTORED EACH TIME. THESE FACTS ARE THE BASIS FOR THIS FORMAL COMPLAINT WITH AMEREN, U.E.

3. The Complainant has taken the following steps to present this complaint to the Respondent:

HIGHLIGHTING OUR PLIGHT IN THIS AREA,

I HAVE A PETITION FROM OUR
