On April 18, 2018, the regulatory judge issued *Notice of Abeyance and Order Directing Filing*, which stated in part: "The Commission will hold this case in abeyance pending resolution of the complaint case. The Commission will also direct the parties to file a response to this order upon final disposition in the complaint case." The notice of abeyance ordered that, "[u]pon a final disposition in File No. EC-2018-0113, the parties shall file a response to this order suggesting further procedure."

On May 29, 2018, a notice of dismissal was filed in case EC-2018-0113. The Commission will direct the parties to file a response to the April 18, 2018, *Notice of Abeyance and Order Directing Filing*.

THE COMMISSION ORDERS THAT:

1. The parties shall file, no later than June 25, 2018, a response to *Notice of Abeyance and Order Directing Filing*.

2. This order shall be effective when issued.
