On September 20, 2018, Union Electric Company d/b/a Ameren Missouri (Ameren Missouri) filed a request for variances. In its request, Ameren Missouri asked that the Commission grant it additional time, until March 31, 2019, to complete the annual inspection process described in 4 CSR 240-23.020. Ameren Missouri also requested a waiver for good cause of the 60-day notice requirement in 4 CSR 240-4.017(1)(D). The Commission will direct the Staff of the Missouri Public Service Commission to file a recommendation or a status report stating when it expects to file a recommendation.
