MOTION FOR WAIVER OF FILING OF EVIDENCE OF FINANCIAL RESOURCES

Velocity The Greatest Phone Company Ever, Inc. ("Applicant" or "Velocity"), a Delaware Corporation, hereby moves for a waiver of the requirements of 4 CSR 240-3.510(D)(1), concerning evidence of financial resources, and files herewith the affidavit of Gregory Kiley to demonstrate its financial ability to provide basic local telecommunications service in Missouri. In support of this Motion, Velocity states the following:

1. Velocity filed its application on October 13, 2009, and an amendment to the application on November 17, 2009.

2. Under 4 CSR 240-3.510(D)(1), applicants for basic local exchange authority are required to file certain financial information, for the purpose of demonstrating their ability to provide basic local exchange service. Velocity hereby requests a waiver of that requirement, and submits for the Commission's consideration the affidavit of Gregory Kiley, in which Mr. Kiley swears that Velocity has the financial ability to provide basic local exchange service in Missouri. It has not defaulted on any financial obligation within the past three years, and has access to sufficient financial resources to support its provision of local exchange services. Given the content of Mr. Kiley's affidavit, the financial information require by the rule is unnecessary.

Wherefore, for good cause shown Velocity moves for waiver of 4 CSR 240-3.510(D)(1)

and requests that the Commission consider the attached affidavit of Gregory Kiley in support of its application.

AFFIDAVIT OF GREGORY KILEY


Comes now Gregory Kiley, being of lawful age and duly sworn, who swears and affirms as follows:
