## STAFF RECOMMENDATION RESPECTING TARIFF SHEET

Comes now the Staff of the Missouri Public Service Commission (Staff) and files its Memorandum Recommendation (Appendix A hereto) respecting the tariff sheet filed on April 4, 2006 by Kansas City Power & Light Company (KCPL), File No. JE-2006-0755, with a proposed effective date of May 5, 2006, as authorized by the Commission in its Order Approving Proposed Rate Schedule And Special Contract issued March 16, 2006, effective March 26, 2006. On April 13, 2006, KCPL filed a substitute tariff sheet as requested by the Missouri Public Service Commission Energy Department Staff (Staff).1

The proposed tariff sheet lists both the special contract approved in Case No. EO-2006-0192 and the special contract approved in Case No. EO-2006-0193. The identity of the customer and the specific terms of the Special Contract are designated as Highly Confidential and filed under seal. KCPL stated in its Application, "This practice of identifying the case number, but not the name of the specific customer that is a party to the Contract, has been customarily used by KCPL and approved by the Commission with regard to other Special Contracts in past cases."

(The Staff notes that the illustrative tariff sheet filed by KCPL in Case No. EO-2006-0192 and the illustrative tariff sheet filed by KCPL in Case No. EO-2006-0193 are identical, each containing space for the two separate case numbers.)

Wherefore the Staff files its Memorandum Recommendation (Appendix A hereto) recommending that the Commission issue an order approving the proposed tariff sheet, as filed on April 4, 2006, and substituted on April 13, 2006 by Kansas City Power & Light Company, File No. JE-2006-0755, to become effective on May 5, 2006.
