Request for Leave to Withdraw Intervention
Pemiscot-Dunklin Electric Cooperative

Comes now Pemiscot-Dunklin Electric Cooperative, pursuant to 4 CSR 240-2.080, and hereby requests leave from the Commission to withdraw its intervention, party status, and opposition to the change of power suppliers requested herein.

In support of this Request, Pemiscot-Dunklin states that the City of Campbell has recently indicated to Pemiscot-Dunklin that it has accepted a bid from Ozark Border Electric Cooperative to purchase the electrical distribution system from the City in preference to Pemiscot-Dunklin's existing contract to purchase same.

As the City no longer desires Pemiscot-Dunklin to purchase the facilities serving the Applicant, and no longer desires Pemiscot-Dunklin to provide electrical service to the Applicant, in reliance upon this change of status Pemiscot-Dunklin no longer opposes Applicant's request.

WHEREFORE, on the basis of the foregoing, Pemiscot-Dunklin respectfully requests that the Commission grant it leave to withdraw its intervention in this case, remove Pemiscot-Dunklin as a party to this case, and withdraw Pemiscot-Dunklin's opposition to Applicant's request herein.
