MOTION FOR LEAVE TO FILE PROPOSED FINDINGS OF FACT AND CONCLUSIONS OF LAW ONE DAY LATE

COMES NOW the Staff of the Missouri Public Service Commission, by and through counsel and, for its Motion for Leave to File Proposed Findings of Fact and Conclusions of Law One Day Late, states to the Missouri Public Service Commission as follows.

- 1. On December 22, 2006, the Commission issued its Order Setting Briefing Schedule and Directing the Filing of Proposed Findings of Fact and Conclusions of Law, wherein it directed all parties to file proposed findings of fact and conclusions of law regarding the resolution of this case no later than January 19, 2007.
- 2. Due to the press of other business, including the preparation of the Staff's Brief for the instant case, which was due and was filed on January 19, 2007, and preparation for the evidentiary hearing in the Algonquin Water Resources of Missouri rate case (Case No. WR-2006-0425), which is scheduled to begin on January 22, 2007, the Staff was not able to complete and file its Proposed Findings of Fact and Conclusions of Law in this case by January 19, 2007, as ordered by the Commission.

3. The Staff has now completed preparation of the Proposed Findings of Fact and Conclusions of Law for this case, and is filing them contemporaneously herewith. The Staff submits that there was good cause for the short delay in filing this pleading, and that no party will be harmed by the one-day delay in filing the Proposed Findings of Fact and Conclusions of Law.

4. The Staff therefore respectfully requests that the Commission extend, by one day, the deadline for the Staff to file its Proposed Findings of Fact and Conclusions of Law in this case, so that the said pleading may be filed on January 22, 2007.

WHEREFORE, the Staff respectfully requests that the Commission issue an order consistent with the request set forth in Paragraph 4 herein.
