**JOINT MOTION FOR MODIFICATION OF PROCEDURAL SCHEDULE**

**COMES NOW** the Staff of the Missouri Public Service Commission, on its own behalf and on behalf of Central Jefferson County Utilities, Inc., Jefferson County Public Sewer District, the Office of the Public Counsel, the Missouri Department of Natural Resources, and Raintree Plantation Property Owners Association, being all of the parties in this case and, for its Joint Motion for Modification of Procedural Schedule, states to the Missouri Public Service Commission as follows:

1. On October 10, 2006, the Commission issued its Order Adopting Procedural Schedule, in which, among other things, it ordered the parties to file an Issues List, Order of Witnesses, and Order of Cross by no later than November 22, 2006, and ordered the parties to file their Position Statements by no later than November 29, 2006.

2. The parties have unanimously agreed that they need additional time to identify the issues that need to be presented in this case. The parties therefore request that the date for filing the Issues List, Order of Witnesses, and Order of Cross be extended by nine days, to December 1, 2006, and that the date for filing the Position Statements be also extended by nine days, to December 8, 2006.

3. The requested extensions of time will allow the parties to more fully develop the issues to be presented at the hearing of this case, and will not be prejudicial or detrimental to any of the parties or to the Commission, in that the parties' positions will still be disclosed a full 11 days before the start of the hearing, which is scheduled to begin at 8:30 a.m., on December 19, 2006.

**WHEREFORE**, based on the foregoing, the Staff, on behalf of itself, Central Jefferson County Utilities, Inc., Jefferson County Public Sewer District, the Office of the Public Counsel, the Missouri Department of Natural Resources, and Raintree Plantation Property Owners Association, respectfully requests that the Commission issue an order extending the date for filing the Issues List, Order of Witnesses, and Order of Cross to December 1, 2006, and extending the date for filing the Position Statements to December 8, 2006.
