grant Stella Lucy the relief which she has requested. The Parties shall specifically address the issue of whether the Company's conduct and/or Stella Lucy's transfer switch caused or contributed to cause Stella Lucy's alleged injuries and damages.

- The Parties shall identify, with arguments and reasons, the statutes, regulations and/or tariffs which each believe govern the disposition of this case. The Parties shall specifically identify the Company's duties, if any, in this case.
- The Parties shall identify, with arguments and reasons, the material facts in evidence which they contend govern the disposition of this case.
