**Application to Intervene  
Opposition to Change of Electric Supplier**

Comes now Pemiscot-Dunklin Electric Cooperative, pursuant to 4 CSR 240-2.075, and in response to the Commission's August 31, 2009 Notice of Request for Change of Electric Suppliers. Pemiscot-Dunklin opposes the Request, and for its application to intervene in opposition thereto states as follows:

1. Pemiscot-Dunklin Electric Cooperative "Pemiscot" is a Missouri corporation organized and operating as a Rural Electric Cooperative pursuant to Chapter 394 RSMo. Pemiscot provides electrical service in the Missouri counties of Pemiscot, Dunklin, and New Madrid. Pemiscot's principal office and place of business is located at 2801 West Highway 84, Bragg City, Missouri, 63827.

2. Pemiscot is a Missouri corporation in good standing with the State of Missouri as set forth in Attachment A, Pemiscot's Certificate of Good Standing from the Secretary of State.

5. On or about August 28, 2009, Richard D. Lewis applied to this Commission for an order authorizing them to change his retail electrical energy supplier from the City of Campbell, Missouri, to Ozark Border Electric Cooperative.

6. On or about August 31, 2009, this Commission issued a Notice of request directing that any responses to Mr. Lewis' application should be filed no later than September 30, 2009.

7. Pemiscot respectfully opposes Mr. Lewis' application on the following grounds:

- a. the City of Campbell in the past has operated a municipal utility distributing electrical energy to its citizens, but has determined to exit that business;
  - b. pursuant to the City's determination, the City of Campbell and Pemiscot have entered into, but not closed, a contract whereby Pemiscot would acquire the assets of the City and thereafter see that electrical energy is distributed to the residents of the City of Campbell.
  - c. subsequent to the execution of said contract, the voters of the City of Campbell by voter referendum, or ballot, have approved such agreement;
  - d. Pemiscot has a contractual interest in providing electrical energy to Applicants;
  - e. the City of Campbell and Pemiscot are cooperating to complete the matters necessary to close the agreement, which matters may include returning to the Commission for some type of notice or approval, the specifics of which have not been mutually agreed to as of the date of this filing.
5. As Pemiscot has an interest in providing electrical service to Applicants, Pemiscot's interests are different from that of the general public.
6. The granting of the relief requested by Applicant would be adverse to Pemiscot's interests. Pemiscot respectfully states that it is entitled to intervene in this matter.
7. Pemiscot has no pending actions or final unsatisfied judgments or decisions against it from any state or federal agency or court that involve customer service or rates that have occurred within three years of the date of this Application.

8. Pemiscot has no annual report or assessment fees which are overdue this Commission.

WHEREFORE, on the basis of the foregoing, Pemiscot respectfully requests that its application to intervene be granted, and that it be allowed to participate as a party herein opposing the relief Applicant has requested.

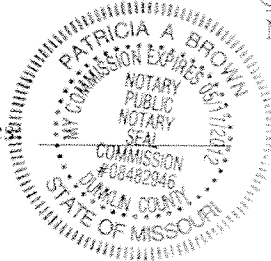
