CORRECTED EXHIBIT 201

COMES NOW the Staff of the Missouri Public Service Commission (“Staff”), by and through counsel, and for its *Corrected Exhibit 201* states as follows:

1. During the evidentiary hearing in this docket, Staff noted two corrections to its Staff Report filed on April 27, 2020.
2. The first correction, as noted in the trial transcript,¹ is on page 7 of Staff’s Report.
3. As filed, the report reads “Although Ms. Edwards was responsible for reading and reporting her reads, the Company did not obtain a reading for the **entire year** of 2018 and half of 2019.”
4. During her testimony, Staff witness Tammy Huber corrected the report to read “Although Ms. Edwards was responsible for reading and reporting her reads, the Company did not obtain a reading for **most** of 2018 and half of 2019.”

5. Following questioning from Judge Jacobs, Ms. Huber also clarified the following line from page 6 of Staff's Report,² which reads "Evergy last obtained a read from Ms. Edwards on November 11, 2017."

6. The line should read "Evergy last obtained a **physical** read from Ms. Edwards on November 11, 2017."

7. Staff has made the above corrections to the Staff Report, attached as Corrected Exhibit 201 (Confidential).

WHEREFORE, Staff respectfully submits its *Corrected Exhibit 201* for the Commission's consideration and knowledge.
