**NOTICE ACKNOWLEDGING DISMISSAL OF COMPLAINT
AND CLOSING FILE**

Issue Date: August 4, 2022

On April 19, 2022, Glory Pittsenbarger filed a complaint against The Empire District Electric Company d/b/a Liberty (Liberty). On July 13, the Commission issued its Order Setting Procedural Schedule, setting an evidentiary hearing for 9:00 a.m. on August 8. On July 29, the Commission suspended the procedural schedule as the parties reached a tentative agreement. On August 4, the parties filed a Joint Dismissal With Prejudice.

Commission Rule 20 CSR 4240-2.116(1) provides that a complainant may voluntarily dismiss its complaint at any time before prepared testimony has been filed or oral evidence has been offered, without an order from the Commission. No prepared testimony has been filed in this case and no oral evidence has been offered, so the Commission will acknowledge Complainant’s dismissal of its complaint. This file may now be closed.
