On August 23, 2023, the Commission granted Union Electric Company d/b/a Ameren Missouri's motion to compel Complainant to answer four outstanding data requests. The Commission directed Complainant to provide answers to outstanding data requests no later than August 25, 2023. Complainant filed some information related to the four outstanding data requests. However, Complainant refused to provide other information responsive to outstanding data requests.

The Commission will cancel the evidentiary hearing set for August 30, 2023, and schedule a prehearing conference for that time instead.
