NOTICE OF DEFICIENCY IN APPLICATION TO INTERVENE

Issue Date: May 25, 2023

On May 23, 2023,¹ Brett Felber filed a complaint with the Missouri Public Service Commission against Union Electric Company d/b/a Ameren Missouri. On May 25, Capital Property Investors LLC and Dividend Park Investors LLC filed an application to intervene. Capital Property Investors LLC and Dividend Park Investors LLC’s request is signed by Lisa Lambert. Lisa Lambert is not identified as an attorney licensed to practice law in Missouri or any other state.

Missouri statute Section 484.020, RSMo (2016), restricts the practice of law to licensed attorneys. Consequently, Commission Rule 20 CSR 4240-2.040(5), requires pleadings filed with the Commission to be signed by an attorney authorized to practice law in Missouri unless the entity signing the pleading is a natural person acting solely on his or her own behalf and representing only him or herself.² Capital Property Investors

LLC and Dividend Park Investors LLC's motion to intervene is signed by Lisa Lambert, who is not identified as an attorney licensed to practice in Missouri. The present motion to intervene is filed on behalf of the corporations, Capital Property Investors LLC and Dividend Park Investors LLC, rather than by Lisa Lambert as a natural person on their own behalf.

Therefore, Capital Property Investors LLC and Dividend Park Investors LLC's filing is deficient and the Commission cannot take action on the motion to intervene until this deficiency is corrected.
