ORDER DIRECTING EXPEDITED RESPONSE

On August 29, 2023, The Staff of the Commission (Staff) filed *Staff Response, Motion for Expedited Treatment and Motion for Injunction*. Staff’s motion states that Evergy Metro, Inc. d/b/a Evergy Missouri Metro and Evergy Missouri West, Inc. d/b/a Evergy Missouri West (collectively “Evergy”) has a condemnation hearing in circuit court on September 6, 2023, that might cause irreparable harm to Complainant and his neighbors. Staff seeks to have the Commission direct its General Counsel to pursue an injunction.

Commission Rule 20 CSR 4240-2.080(13) allows parties ten days to respond to any pleading unless another response time is established by the Commission. The Commission will shorten the time for any responses to Staff’s motion.

1. Any responses to *Staff Response, Motion for Expedited Treatment and Motion for Injunction* are due no later than August 30, 2023.
