On May 3, 2023, the Staff of the Commission (Staff) filed its recommendation for the Commission to deny the application of John J. Lindsay for change of electric supplier, filed on February 16, 2023. Any party wishing to respond to Staff's recommendation has 10 days to do so, pursuant to Commission Rule 20 CSR 4240-2.080(11). Parties may respond to Staff's recommendation, although it is not required. The 10-day period for responding ends on Saturday, May 13, 2023, so responses are due no later than Monday, May 15, 2023.<sup>1</sup>

- 1. Any party wishing to respond to Staff's recommendation shall do so no later than May 15, 2023.
