On July 13, 2023, the Commission issued its order setting a procedural schedule in this matter, setting an evidentiary hearing on September 19, 2023.

On August 29, 2023, the Empire Electric Company d/b/a Liberty filed a motion to stay the proceedings, suspend the procedural schedule, and cancel the currently scheduled hearing date, to allow more time to discuss the resolution of Mr. Lindsay's application.
