ORDER STAYING PROCEEDINGS

On July 13, 2023, the Commission issued its order setting a procedural schedule in this matter, setting an evidentiary hearing on September 19, 2023.

On August 29, 2023, the Empire Electric Company d/b/a Liberty filed a motion to stay the proceedings, suspend the procedural schedule, and cancel the currently scheduled hearing date, to allow more time to discuss the resolution of Mr. Lindsay’s application. Liberty explains that it has obtained the agreement or non-objection of John Lindsay, the Staff of the Commission, and New-Mac Electric Cooperative, and that a stay will not prejudice any party and will make the best use of the parties’ time and resources.

The Commission finds Liberty’s motion to be reasonable and will grant it.

THE COMMISSION ORDERS THAT:

1. Proceedings in this matter, File No. EO-2023-0266, are stayed, and the scheduled evidentiary hearing is cancelled, until further order of the Commission.
2. The Commission’s Staff shall file a status report by September 29, 2023.
3. This Order shall be effective when issued.
