STAFF RECOMMENDATION TO APPROVE TARIFF SHEETS

COMES NOW the Staff (Staff) of the Missouri Public Service Commission (Commission), and for its Staff Recommendation To Approve Tariff Sheets states:

- 1. On February 29, 2012, the Commission issued its *Report and Order Approving Seventh Territorial Agreement* in this case. The *Report and Order* required Empire District Electric Company (Empire) to file revised tariff sheets amending any descriptions of its service territory in Christian and Taney Counties, Missouri, that may be affected by the new territorial agreement.
- 2. On March 14, 2012, Empire filed tariff sheet revisions, which were subsequently amended on March 28 and March 29, 2012.
- 3. On April 2, 2012, the Commission issued its *Order Directing Staff to File A Recommendation and Setting Deadline for Responses*, which directed Staff to review the tariff sheets filed by Empire and to file a recommendation, no later than April 16, 2012, as to whether the tariff sheets are in compliance with the Commission's February 29, 2012, *Report and Order*.
- 4. Staff reviewed the tariff sheets filed by Empire and found that they are filed in a timely manner and are in compliance with the Commission's *Report and Order*.

5. In the Memorandum attached here as Appendix A, Staff recommends that the Commission issue an order approving the tariff sheets as filed on March 14, 2012, and substituted on March 28 and 29, 2012, to become effective on April 13, 2012, as requested by Empire, or permit the tariff sheets to go into effect by operation of law.

6. Staff has verified that Empire is not delinquent on any assessment or the filing of its annual report. Further, Staff is not aware of any other matter pending before the Commission that affects, or is affected by, this tariff filing.
