**ORDER DIRECTING NOTICE AND SETTING INTERVENTION DATE**

On December 28, 2007, Aquila, Inc. filed a tariff with the Missouri Public Service Commission to establish rate schedules to adjust charges related to Aquila's approved Fuel Adjustment Clause (FAC). The rate schedules increase charges related to the FAC by approximately \$12.5 million for the MPS division and approximately \$3.3 million for the L&P division.

The Commission will give notice of the filing of this tariff to the public and to others who may be interested. The Commission will also set a date for the filing of intervention requests.

**IT IS ORDERED THAT:**

1. The Data Center of the Missouri Public Service Commission shall mail a copy of this notice to the County Commission for each of the counties in Aquila, Inc.'s

service area. In addition, the Data Center shall mail a copy of this notice to each party in ER-2007-0004, Aquila, Inc.'s last general rate case.

2. The Information Officer of the Missouri Public Service Commission shall make notice of this order available to the media serving Aquila, Inc.'s service area and to the members of the General Assembly representing Aquila, Inc.'s service area.
