ORDER APPROVING TARIFF

Issue Date: February 18, 2009

Effective Date: February 26, 2009

On March 28, 2008, Union Electric Company, d/b/a AmerenUE (hereafter "AmerenUE") and Pemiscot-Dunklin Electric Cooperative, Inc., (hereafter "PDEC") submitted to the Commission a Joint Application. The joint applicants wanted to transfer approximately 2,700 Dunklin County customers from AmerenUE to Pemiscot-Dunklin. To accomplish such a transfer, the joint applicants sought Commission approval of their request for a change in the electric supplier for those customers, approval for the sale of certain AmerenUE assets to Pemiscot-Dunklin, and approval of a territorial agreement between the applicants.

On June 11, 2008, AmerenUE, PDEC, the Staff of the Commission (hereafter "Staff") and the Office of the Public Counsel (hereafter "OPC") filed a Unanimous Stipulation and Agreement. The Commission approved that agreement on June 24, 2008.

In the order approving the agreement, the Commission ordered AmerenUE to file updated tariff sheets that reflect the changes in its service territory due to the

above-described agreement with PDEC. AmerenUE filed such an updated tariff sheet on January 26, 2009, and the tariff sheet bears an effective date of February 26, 2009.

On February 11, 2009, the Staff of the Commission filed its Recommendation. Staff advises the Commission to approve the tariff sheet.

The Commission has reviewed the tariff sheet and Staff's recommendation and finds that the tariff sheet conforms to the Commission's order. The Commission will approve the tariff sheet.

THE COMMISSION ORDERS THAT:

1. The tariff Union Electric Company, d/b/a AmerenUE, filed on January 26, 2009, which was assigned tariff number YE-2009-0546, is approved to become effective on February 26, 2009. The tariff approved is:
