## ORDER APPROVING UNANIMOUS STIPULATION AND AGREEMENT AND APPROVING TARIFF

Issue Date: July 1, 2009 Effective Date: July 9, 2009

On May 14, 2009, Union Electric Company, d/b/a AmerenUE issued a revised Rider L tariff. The revised Rider L tariff would provide credits to large customers who, at the company's request, voluntarily reduce their normal electrical usage. On June 10, in response to motions to suspend filed by Staff and the Office of the Public Counsel, the Commission suspended AmerenUE's tariff until July 9.

On June 22, AmerenUE, Staff, and Public Counsel filed a unanimous stipulation and agreement regarding AmerenUE's tariff. In the stipulation and agreement, AmerenUE agreed to make certain revisions in its tariff to satisfy the concerns of Staff and Public Counsel. Subsequently, in compliance with the stipulation and agreement, AmerenUE withdrew its previous tariff and issued a new tariff with an effective date of July 22. The stipulation and agreement asks the Commission to approve that revised tariff to take effect on July 9.

The stipulation and agreement appears to be a reasonable resolution of Staff and Public Counsel's concerns about AmerenUE's Rider L tariff, and will allow AmerenUE to

implement and evaluate a useful new demand response program. For those reasons, the Commission will approve the stipulation and agreement and the revised tariff submitted by AmerenUE.

## THE COMMISSION ORDERS THAT:

- 1. The unanimous stipulation and agreement filed on June 22, 2009, is approved. A copy of the stipulation and agreement is attached to this order.
- 2. The signatory parties are ordered to comply with the terms of the stipulation and agreement.
- 3. The tariff issued on June 22, 2009, by Union Electric Company, d/b/a AmerenUE, and assigned Tariff No. YE-2009-0874, is approved to be effective July 9, 2009. The tariff approved is:
