JOINT PROPOSED PROCEDURAL SCHEDULE

COMES NOW, the Staff of the Missouri Public Service Commission (“Staff”), by and through the undersigned counsel, and on the behalf of the Staff, Mr. Gary Roof, Platte-Clay Electric Cooperative, Inc. (“Platte-Clay”) and Union Electric Company, d/b/a AmerenUE (“AmerenUE”), known jointly as “the Parties,” files this *Joint Proposed Procedural Schedule* with the Missouri Public Service Commission (“Commission”), respectfully stating the following:

Procedural Background

1. On November 30, 2009, Mr. Roof filed an *Application For Change Of Electric Service Provider* (“*Application*”) to allow a change of supplier from Platte-Clay to AmerenUE. Mr. Roof cites reliability concerns as the reason for the *Application*.

2. On February 5, 2010, the Commission issued its *Order To File Proposed Procedural Schedules*, directing the Parties to file responses by February 18, 2010, including suggested dates for a prehearing conference, and evidentiary hearing, and any other events the Parties deem helpful.

Proposed Procedural Schedule

3. The Parties recommend the following schedule:

(a) A prehearing on March 23, 2010, beginning at 10 a.m., to accommodate those traveling from out-of-town. To date, no conflicts appear on the Commission’s calendar for Hearing Room 305;

(b) The Parties request that the Commission allow the option of appearance by telephone for the prehearing;

(c) The Parties agree to tentatively set a one-day evidentiary hearing in this matter for April 13, 2010, beginning at 10 a.m., to accommodate those traveling from out-of-town. To date, no conflicts appear on the Commission's calendar for Hearing Room 305. The Parties use the term "tentatively," requesting the Commission allow the Parties' reservation of the ability to stay or reschedule the hearing based on any discussions that occur at the prehearing conference. Mr. Roof has stated appearance by telephone is the most convenient for him. While the remaining Parties do not make a recommendation on the method of appearance for the evidentiary hearing, the Parties do not object to such option being allowed.

(d) The Parties agree to file a joint list of issues, witnesses, and order of cross examination on or before March 30, 2010, for an April 13, 2010 evidentiary hearing.

WHEREFORE, the Counsel for Staff, on behalf of the Parties, requests that the Missouri Public Service Commission issue an order which 1) sets the prehearing in this matter for March 23, 2010, beginning at 10 a.m.; 2) directs the manner in which the parties will participate in both the prehearing and evidentiary hearings; 3) sets the evidentiary hearing for April 13, 2010, allowing the Parties to request other relief should the prehearing discussion produce such; and 4) directs the Parties to jointly file a list of issues, witnesses, and order of cross examination on or before March 30, 2010, for an April 13, 2010 evidentiary hearing.
