On March 24, 2010, Union Electric Company, d/b/a AmerenUE (hereafter "AmerenUE"), submitted an Application to the Commission. AmerenUE wants to transfer certain of its assets to St. James Municipal Utilities (hereafter "St. James") and Rolla Municipal Utilities (hereafter "Rolla"), two wholesale customers of AmerenUE.

The Commission finds that proper persons should be allowed 20 days from the issuance of this order to file a motion for leave to intervene.
