ORDER DIRECTING NOTICE, SETTING DEADLINE FOR INTERVENTION REQUESTS, AND DIRECTING FILING

On December 10, 2021, Gridliance High Plains LLC (Gridliance HP) filed an application with the Missouri Public Service Commission for approval of the sale of certain public utility assets. Gridliance HP requests the Commission grant it authority to sell approximately 10 miles of 69 kV transmission lines and related facilities located in Christian and Greene Counties to the Missouri Joint Municipal Electric Utility Commission (MJMEUC).

The Commission will direct notice of the application be given to the county commission and county clerk of Christian and Greene Counties, Missouri, newspapers local to those counties, and members of the General Assembly representing residents of those counties. The Commission will also set a deadline for interested parties to intervene and direct its Staff to file a recommendation with regard to the application.

THE COMMISSION ORDERS THAT:

1. The Commission's Data Center shall provide a copy of this order to the county commission and county clerk of Christian County and Greene County.

2. The Commission's Public Policy and Outreach Division shall make notice of this order available to the members of the General Assembly representing Christian County and Greene County, and to the media serving those counties.

3. Any application to intervene shall be filed no later than January 18, 2022.

4. No later than January 26, 2022, the Staff of the Missouri Public Service Commission shall file a recommendation or status report stating when it expects to file its recommendation.

5. This order shall be effective when issued.
