### **ORDER ESTABLISHING A PROCEDURAL SCHEDULE FOR ON-THE-RECORD PRESENTATIONS**

Effective Date: March 15, 2007

On February 16, 2007, the Commission set dates for holding on-the-record presentations in these matters. An on-the-record proceeding is set for April 25, 2007, for

Case Nos. EO-2006-0493, EO-2006-0496, and EO-2006-0497. An on-the-record proceeding is set for April 27, 2007, for Case Nos. EO-2006-0494 and EO-2006-0495.

The purpose of these proceedings is to allow the parties' representatives and experts to address the Commission's threshold question on the applicability of the prior state action exemption to the adoption of the PURPA standards noted in each respective case caption. A decision by the Commission that prior state action has satisfied EPCRA's current requirements would terminate these proceedings, while an opposite decision would require the Commission to initiate rulemaking for the purposes of adopting the standards.

To help facilitate these proceedings, the Commission will establish a procedural schedule where the parties will identify any experts they anticipate they will offer to provide testimony at the proceedings. Additionally, the parties will prefile the identified experts' positions on the threshold question for each case, as delineated above, and the reasons for supporting those positions. There will be no responsive pleadings filed.

**IT IS ORDERED THAT:**

1. No later than April 6, 2007, the parties shall file with the Commission a list of any experts, and their biographical backgrounds, that they intend to tender for the Commission's on-the-record proceedings scheduled in these matters.

2. No later than April 13, 2007, the parties shall file with the Commission position statements from their identified experts, outlining the experts' positions on the applicability of the prior state action exemption to the adoption of the PURPA standards noted in each respective case caption, and articulating the reasons for supporting those positions.

3. This order shall become effective on March 15, 2007.
