**REQUEST FOR EXTENSION OF TIME  
TO FILE STAFF RECOMMENDATION**

COMES NOW, the Staff of the Public Service Commission of the State of Missouri, and in response to the Order Directing Staff to Investigate and File a Report issued by the Commission on the 27<sup>th</sup> day of February, 2007, respectfully asks the Commission to grant an Extension of Time to File Staff Recommendation, and further states:

1. The Order Directing Staff to Investigate and File a Report required the Staff of the Public Service Commission to fully investigate the circumstances surrounding Thomas A. Marshall's application for change of electric service provider, and file a Report concerning the results of that investigation, as well as a recommendation as to whether the application should be approved, no later than the 10<sup>th</sup> day of April, 2007.

2. Staff has indicated that it would like additional time to further investigate the circumstances of the application, to meet with the parties involved, to physically inspect the site, and then file a Report, and respectfully asks the Commission to grant a Request for Extension of Time to File Report until the 1<sup>st</sup> day of May, 2007.

4. In making its Request for Extension of Time, Staff Counsel has not consulted counsel for the SEMO Electric Cooperative, the Sikeston Board of Municipal Utilities, or Thomas A. Marshall. Staff proposes, if the Commission deems it necessary, that if counsel for SEMO Electric Cooperative, the Sikeston Board of Municipal Utilities, or Thomas A. Marshall have an

objection to this Request for Extension of Time, that they make a written objection and duly file that objection with the Commission.

WHEREFORE Staff requests that the Commission issue an Order authorizing Staff to late file its Report and setting the new date for filing of the Report to May 1, 2007.
