ORDER SHORTENING TIME AND DIRECTING RESPONSES TO COMPLIANCE TARIFF FILING

On November 10, 2022, Evergy Metro d/b/a Evergy Missouri Metro (EMM) filed an application asking the Commission to approve a Special High Load Factor Market Rate. EMM filed exemplar tariff sheets as attachment BDL-1 to witness Brad Lutz's prefiled direct testimony. On May 24, 2023, the Commission issued its *Order Approving Stipulation and Agreement* (Order) approving a settlement among the parties and authorizing the Company to submit tariff sheets in compliance with the Order.

On June 13, 2023, EMM filed tariff sheets purported to be in compliance with the Order. The submitted tariff sheets carry a 30-day effective date of July 13, 2023, and are assigned Tracking No. YE-2023-0217.

The Commission will direct the Staff of the Commission (Staff) to file an expedited recommendation as to whether the tariff sheets comply with the Commission's Order. The Commission will also shorten the timeline for other responses.

THE COMMISSION ORDERS THAT:

- 1. On or before June 23, 2023, Staff shall file a recommendation as directed in the body of this order, or a request for additional time if needed.
 - 2. Any other party wishing to file objections or a recommendation regarding

EMM's compliance tariff sheet filing shall do so on or before June 23, 2023.
