ORDER DIRECTING RESPONSES

Issue Date: December 20, 2022

Effective Date: December 20, 2022

On August 8 through August 10, 2022, fifteen (15) individuals or couples (Applicants) filed a request for a change of electric supplier from the City of Butler, Missouri (“City of Butler”) to the Osage Valley Electric Cooperative Association (“Osage Valley”). The

Applicants indicated that they needed to change service providers in order for new construction on their collective properties to be permitted to receive electric services.

On October 5, City of Butler filed their Joint Application for approval of a territorial agreement in File No. EO-2023-0126. That territorial agreement purports to assign the right to provide electric service to all of the Applicants herein mentioned to City of Butler. Proceedings in the cases filed by the Applicants were stayed on October 25, so the Commission could evaluate the territorial agreement independently from the Applicants' applications for change of electric supplier. The Commission issued an order in that case directing the Commission's Data Center to send a copy of the Joint Application in that matter to all applicants in these cases on October 7.

The Commission will direct the Applicants in File Numbers EO-2023-0039, EO-2023-0040, EO-2023-0041, EO-2023-0042, EO-2023-0043, EO-2023-0044, EO-2023-0045, EO-2023-0046, EO-2023-0047, EO-2023-0048, EO-2023-0049, EO-2023-0050, EO-2023-0051, EO-2023-0063, and EO-2023-0064 to file a response to this Order stating whether they wish to proceed with their application for change of electric supplier, or to dismiss their application in light of the pending territorial agreement submitted by City of Butler and Osage Valley in File No. EO-2023-0126.

Failure of an applicant to respond may result in the dismissal of their case pursuant to 20 CSR 4240-2.116.

THE COMMISSION ORDERS THAT:

1. No later than January 13, 2023, applicants in File No's. EO-2023-0039, EO-2023-0040, EO-2023-0041, EO-2023-0042, EO-2023-0043, EO-2023-0044, EO-2023-0045, EO-2023-0046, EO-2023-0047, EO-2023-0048, EO-2023-0049, EO-2023-0050, EO-

2023-0051, EO-2023-0063, and EO-2023-0064, shall file a response to this Order stating whether they wish to proceed with their application for change of electric supplier, or to dismiss their application in light of the pending territorial agreement submitted by City of Butler and Osage Valley in File No. EO-2023-0126.

2. This order shall be effective when issued.
