ORDER APPROVING FUEL ADJUSTMENT TRUE-UP

Issue Date: February 22, 2023

Effective Date: March 4, 2023

On December 30, 2022, Evergy Missouri West, Inc. d/b/a Evergy Missouri West (Evergy West) initiated a rate adjustment mechanism true-up in File No. EO-2023-0206. The true-up amount identified is the result of an under-collection of \$169,679 from customers during Recovery Period 28 from September 1, 2021 through August 30, 2022 (RP28). The true-up amount for RP28 is included in the preliminary calculation of the Fuel and Purchased Power (“FPA”) amount included in Evergy West’s Accumulation Period 31 (AP31) Fuel Adjustment Clause (FAC) filing, also filed on December 30, 2022, in File No. ER-2023-0210.

Staff filed its recommendation regarding Evergy West’s true-up on January 30, 2023. In its recommendation, Staff explained that it examined the direct testimony of Lisa A. Starkebaum, supporting schedules, workpapers, and the monthly information Evergy West provided with its application in this case. Further, Staff reviewed the calculations of the corrections and interest amounts in those supporting workpapers. Staff verified that Evergy West has filed its 2021 annual report and is not delinquent on any assessment. Evergy West is current on the filing of its Surveillance Monitoring reports

as required in 20 CSR 4240-20.090(6) and its monthly reports as required by 20 CSR 4240-20.090(5).

Staff notes the true-up amount includes an adjustment of (\$48,796) for 2017 vintage expired RECs as agreed by the parties and approved in File No. EO-2022-0065. Thus, the proposed true-up amount consists of the under-recovery of \$220,443 offset by the ordered adjustment of (\$48,796) and interest on the ordered adjustment of (\$1,968), for a total under-recovery of \$169,679.

Staff recommended the Commission approve Evergy West's RP28 true-up filing for inclusion in the changes in Evergy West's AP31 FAC filing in File No. ER-2023-0210. Ten days have elapsed and no party has responded to Staff's recommendations in File No. EO-2023-0206.

The Commission has reviewed Evergy West's verified application and Staff's verified recommendation and memorandum and finds that the calculations for the true-up amounts for RP28, including the calculation of monthly interest, are correct. Therefore, the Commission will approve Evergy West's true-up filing for RP 28. The Commission's rule requires an order be issued within 60 days of the true-up filing. Therefore, the Commission finds it reasonable to make this order effective in less than 30 days.

THE COMMISSION ORDERS THAT:

1. The true-up amount for Recovery Period 28 is established for Evergy Missouri West as an under-collection of \$169,679 from its customers and shall be reflected in any rate adjustment approved in File No. ER-2023-0210.
2. This order shall become effective on March 4, 2023.

3. This file shall close on March 5, 2023.
