The Information Officer of the Commission is directed to send notice of this application to the members of the General Assembly who represent Barton County, and to the newspapers that serve Barton County as listed in the newspaper directory of the current Official Manual of the State of Missouri.

¹ Pursuant to Section 393.190, RSMo 2000, the Commission is notifying the County Clerk of Barton County that Aguila has identified tax revenue implications of the sale of approximately \$205 for the 2005 tax year.

Proper persons wishing to intervene must file an application to intervene with the Secretary of the Missouri Public Service Commission. Copies of the application to intervene must also be sent to the parties listed below.

The requirement of a hearing has been met when those wishing to be heard are offered an opportunity to be heard. If no proper party requests a hearing, the Commission may determine that a hearing is not necessary and grant the relief requested based upon the verified application.

The Commission would be aided in this matter by receiving a recommendation from its Staff. Therefore, the Commission will direct its Staff to file either its recommendation or a status report indicating when it expects to file its recommendation.
