Staff Recommendation

COMES NOW the Staff of the Missouri Public Service Commission, by and through counsel, and for its *Recommendation*, states as follows:

1. On March 10, 2022, Union Electric Company, doing business as Ameren Missouri, filed its Request for Variance From 20 CSR 4240-22.080(1)(C) and Waiver of 60-Day Notice in 20 CSR 4240-4.017(1), stating that, while its next triennial compliance filing is due by April 1, 2023, it seeks a variance allowing it to make its next filing on or before October 1, 2023, because the results from its latest Demand Side Management potential study will not be available earlier.

On March 11, 2022, the Commission directed notice and ordered 2. interested parties to seek to intervene by March 31, 2022, and for Staff to file its recommendation by April 11, 2022.

3. Only the Missouri Industrial Energy Consumers ("MIEC") timely intervened. MIEC does not oppose Ameren Missouri's request.

4. Because the good cause stated by Ameren Missouri is reasonable, Staff now advises the Commission to APPROVE Ameren Missouri's request.

WHEREFORE, Staff prays that the Commission will APPROVE Ameren Missouri's request to delay its required triennial compliance filing to October 1, 2023; and grant such other and further relief as is just in the circumstances.
