#### ORDER OF RULEMAKING

By the authority vested in the Public Service Commission under sections 386.250 RSMo 2000, the commission amends a rule as follows:

### 4 CSR 240-123.030 is amended.

A notice of proposed rulemaking containing the text of the proposed amendments was published in the *Missouri Register* on November 15, 2007 (32 MoReg 2241). No changes have been made to the proposed amendments, so they are not reprinted here. These proposed amendments become effective thirty (30) days after publication in the *Code of State Regulations*.

SUMMARY OF COMMENTS: A public hearing on the proposed amendments was held December 17, 2007, and the public comment period ended December 17, 2007. No written comments were received and one (1) person testified at the hearing. The person testifying at the hearing was Gene Winn on behalf of the staff of the Missouri Public Service Commission.
