KCPL Filing

On March 4, 2015, KCPL filed with the Commission one (1) tariff sheet bearing an issue date of March, 4, 2015, and an effective date of April 3, 2015, to comply with the Commission's February 18, 2015, *Order Granting Application For Variance* issued in Case No. EE-2015-0177. On March 5, 2015, KCPL filed a substitute tariff sheet to revise the number of residential units shown on it from 14 to 15 after discussion with Staff. When it granted the requested variance, the Commission ordered the following:
