On February 2, 2022, the Commission issued its order in this case directing Staff to file a pleading indicating when it expected to file a recommendation. Staff proposed to file its recommendation no later than April 20, 2022, and the Commission directed Staff to do so. On April 19, 2022, Staff requested two additional months to file its recommendation to allow further discussion between Staff and Evergy. Staff indicates Evergy does not oppose the request for additional time.

The Commission will direct Staff to file a recommendation no later than June 20, 2022.

1. Staff shall file a recommendation in this matter no later than June 20, 2022.
