ORDER SHORTENING TIME FOR RESPONSES

Effective Date: July 14, 2022

On June 1, 2022, the Commission granted Union Electric Company d/b/a Ameren Missouri a temporary waiver from portions of the Emergency Energy Conservation Procedure of its tariff. The waiver is effective through July 23, 2022. Subsequently, Ameren Missouri filed a proposed tariff sheet designed to implement a permanent change to the tariff. The tariff sheet was voluntarily suspended by Ameren Missouri until August 9, 2022. The Commission directed responses to the proposed tariff sheet be filed no later than July 21, 2022.

On July 14, 2022, Ameren Missouri filed a request for an extension of the waiver until August 9, 2022. Ameren Missouri also asked for expedited consideration of the request so that the temporary waiver does not expire before the permanent tariff change becomes effective.

The Commission will shorten the time for responses to Ameren Missouri's request and motion for expedited treatment.

THE COMMISSION ORDERS THAT:

1. Any response to *Ameren Missouri's Request for Extension of Waiver and Motion for Expedited Treatment* shall be filed no later than July 18, 2022.

2. This order is effective when issued.
