ORDER GRANTING MOTION FOR LATE INTERVENTION

On January 4, 2008, Kansas City Power & Light Company submitted an application for the opening of a proceeding, along with its status report on wind investments filed pursuant to KCPL's Regulatory Plan approved by the Commission in Case No. EO-2005-0329. On January 14, 2008, the Commission directed that notice of the status report be given and set an intervention deadline of February 4, 2008.

On February 21, 2008, the Sierra Club and Concerned Citizens of Platte County filed a motion for late intervention. The movants relate that the Sierra Club is a nonprofit corporation incorporated in California with members in Platte County and elsewhere in Missouri, and the Concerned Citizens of Platte County is a nonprofit corporation under the laws of Missouri. Movants state that they have interest in this case that is different from that of the general public in that they are parties to a settlement agreement with KCPL arrived at in the course of litigation arising out of Case No. EO-2005-0329. Movants further state that they wish to intervene in order to protect their interests in their settlement with KCPL. They are unsure of the position they will take in this case.

In support of the motion for late intervention, movants state that they did not, initially, think it necessary to intervene since they were not parties to the stipulation in

EO-2005-0329 and were monitoring their settlement with KCPL, but now feel the need to be fully informed of the developments that gave rise to the present case as they affect that settlement.

No responses to the motion for late intervention have been filed and the deadline for doing so has now passed. The Commission therefore takes up the motion unopposed.

The Commission has reviewed the movants' request to intervene and finds that it complies with the provisions of 4 CSR 240-2.075. The Commission further finds that the Sierra Club and Concerned Citizens of Platte County have an interest in this matter that is different from that of the general public, and that there is good cause to permit them to intervene out of time. The motion for late intervention shall be granted.

IT IS ORDERED THAT:

- The Motion of Sierra Club and Concerned Citizens of Platte County for Late
 Intervention is granted.
- 2. The Sierra Club and Concerned Citizens of Platte County are granted intervention in this case.
 - 3. This order shall become effective on March 17, 2008.
