**STAFF MOTION TO EXTEND FILING DATES FOR BRIEFS BY TWO DAYS**

COMES NOW the Staff of the Missouri Public Service Commission (“Staff”), through the Staff Counsel Office, and submits the instant motion requesting a two-day extension in the filing of the initial and reply briefs in this proceeding. The Staff requests an extension in the filing date of initial briefs from Tuesday, May 18, 2010 to Thursday, May 20, 2010, and an extension in the filing date of reply briefs from Wednesday, June 2, 2010 to Friday, June 4, 2010. In support thereof, the Staff states as follows:

1. At the conclusion of the hearing on Thursday, April 29, 2010, it was announced by the Regulatory Law Judge that the hearing transcripts would be expedited and would be filed on Monday, May 3, 2010, initial briefs would be due Tuesday, May 18, 2010, and reply briefs would be due Wednesday, June 2, 2010.

2. The transcripts of the April 28-29, 2010 hearing were filed on Thursday, May 6, 2010.

3. Due to the delay in the filing of the hearing transcripts and the demands of other Commission work, undersigned Staff counsel asked Counsel for KCPL if KCPL would be amenable to a request by undersigned Staff counsel for a two-day extension in the due dates for initial and reply briefs. Counsel for KCPL has indicated that KCPL has no objection to a two-day extension in the filing dates for initial and reply briefs.

4. Undersigned Staff counsel has also talked with the Public Counsel, and the Public Counsel has indicated that he has no objection to a two-day extension in the filing dates for initial and reply briefs.

5. The Staff does not make this request for an extension in the dates for filing initial and reply briefs to unduly delay these proceedings.

**WHEREFORE** the Staff files its motion requesting an extension in the filing date for initial briefs from Tuesday, May 18, 2010 to Thursday, May 20, 2010 and an extension in the filing date for reply briefs from Wednesday, June 2, 2010 to Friday, June 4, 2010.
